#### **RESOLUTION NO. 265-2020**

#### DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2020 OF SUAL, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P395,000,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Annual Budget for Calendar Year 2020 involving total appropriations of **P395,000,000.00** which was approved on January 20, 2020 through Appropriation Ordinance No. 01;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re "Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects";
- 2. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;

- 3. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
- 4. The preparation of Annual Budget shall be consistent with the Budget Operations Manual for Local Government Units, 2016 Edition;
- The ordinance creating the various positions in the different municipal offices shall be submitted enumerating the qualifications, duties and responsibilities of said positions. Likewise, the ordinance creating the Primary Care Facility-Infirmary Office shall also be submitted;
- 6. The salary grade allocation of the following positions should be adjusted to conform with the provisions of Budget Circular No. 2009-92, dated September 3, 20029, Annex B-Reallocated classes of positions:

Medical Officer IV-SG-20	SG-23
Medical Officer III-SG-18	SG-21

- The appropriation for Representation and Transportation Allowance of the Local Assessment Operations Officer IV, SG 22, shall not be allowed as said position is not considered Municipal Government Assistant Department Head;
- The effect of the adjusted FY 2020 Internal Revenue Allotment shares pursuant to Local Budget Memorandum No. 78-A dated December 17, 2019 particularly the decrease of the IRA of the LGU amounting to P348,579.00 will necessitate the prioritization in the implementation of items of appropriation; and
- 9. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF).

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality and shall notify the offices concerned of the action taken thereon;
