DECLARING ORDINANCE NO. 01-2019 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING PARCELS OF LANDS COVERED BY TCT NO. 028-2017001015, 028-2017001016, 028-2017000397, 028-2017000535, 028-2017000538, 028-2017000701, 028-2017001013, 028-2017001014, 028-2017001247, 028-2018000392 OWNED BY SUPIMA HOLDINGS, INC. WITH AN AGGREGATE AREA OF ONE HUNDRED FIVE THOUSAND EIGHT HUNDRED NINETY (105,890) SQUARE METERS, FROM AGRICULTURAL TO INDUSTRIAL AND PARCELS OF LANDS COVERED BY TCT NOS. 028-2017001017, 028-2017001018, 028-2017000463, 028-2017001000 OWNED BY SUPIMA HOLDINGS AND T-44930, DULY OWNED BY CESAR A. GUTLAY WITH AN AGGREGATE AREA OF THIRTY FIVE THOUSAND SEVEN HUNDRED SIX (35,706) FROM AGRICULTURAL TO COMMERCIAL LAND USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT


WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Officer and Housing and Land Use Regulatory Board, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 20 of RA 7160, subject to compliance with the requirements on land reclassification such as Certification from the Department of Agriculture and the Department of Agrarian Reform;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 01-2019 of the Sangguniang Bayan of **Rosales**, Pangasinan, entitled “An Ordinance reclassifying parcels of lands covered by TCT No. 028-2017001015, 028-2017001016, 028-2017000397, 028-2017000535, 028-2017000538, 028-2017000701, 028-2017001013, 028-2017001014, 028-2017001247, 028-2018000392 owned by Supima Holdings, Inc. with an aggregate area of One Hundred Five Thousand Eight Hundred Ninety (105,890) Square Meters, from agricultural to industrial and parcels of lands covered by TCT Nos. 028-2017001017, 028-2017001018, 028-2017000463, 028-2017001000 owned by Supima Holdings and T-44930, duly owned by Cesar A. Gutlay with an aggregate area of Thirty Five Thousand Seven Hundred Six (35,706) from agricultural to commercial land use” as within the conferred powers of the Sangguniang Bayan to enact;
