RESOLUTION NO. 27-2022

DECLARING MUNICIPAL ORDINANCE NO. 02-2021 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, **ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY** WEARING OF PROPER FACE SHIELDS IN ALL PUBLIC PLACES OF WORK AND **COMMERCIAL** PLACES, AREAS/ESTABLISHMENTS THAT ARE ENCLOSED, HAVE **INADEOUATE** VENTILATION AND WHERE SOCIAL/PHYSICAL DISTANCING IS IMPOSSIBLE, WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF MANGATAREM, **PANGASINAN**" AS WITHIN THE **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Municipal Ordinance No. 02-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1) (iii), (5) (xii) of R.A. No. 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the points raised by the Provincial Legal Officer stated in her opinion dated December 15, 2021;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of RA No. 7160;

> **RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 02-2021 of the Sangguniang Bayan of Mangatarem, Pangasinan, entitled "An Ordinance requiring the mandatory wearing of proper face shields in all public places, places of work and commercial areas/establishments that are enclosed, have inadequate ventilation and where social/physical distancing is impossible, within the territorial jurisdiction of the Municipality of Mangatarem, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
