**PROVINCIAL RESOLUTION NO. 273-2020**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH VARIANCE TRADING CORPORATION FOR THE PROVISION, INSTALLATION, COMMISSIONING, OPERATION AND MAINTENANCE OF TEN (10) HIGH QUALITY DIALYSIS MACHINES TO BE LOCATED AT THE URDANETA DISTRICT HOSPITAL**

**WHEREAS**, in recent years, the Province of Pangasinan has been tremendously embarking on new projects and programs to upgrade and rehabilitate its fourteen provincial government hospitals;

**WHEREAS**, the Provincial Government of Pangasinan has been offered by Variance Trading Corporation for the use of much-needed medical equipment which are necessary and beneficial to patients needing dialysis treatments;

**WHEREAS**, the Province shall, in turn, exclusively purchase from Variance Trading Corporation consumables necessary for the use and operation of the machines during the seven-year agreement period;

**WHEREAS**, the equipment could further enhance better and more accessible ways of public health and medical services to the people of Pangasinan, especially the underprivileged;

**WHEREAS**, in the above purpose, a MOA shall be signed and entered into between the Province of Pangasinan, represented by Provincial Governor Amado I. Espino III, and Variance Trading Corporation, represented by Violeta T. Cariño, President and CEO;


