RESOLUTION NO. 273-2022

DECLARING MUNICIPAL ORDINANCE NO. 6, S-2021 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN, IN THE AMOUNT OF SEVENTY EIGHT MILLION PESOS (P78,000,000.00) APPROVING THE TERMS AND CONDITIONS AND OTHER TERMS AND CONDITIONS OF THE LOAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Municipal Ordinance No. 6, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and Provincial Accountant have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 22 (a) (5) (c), 296 (a) and (b), 297 (a) (b) and (c) and 444 (b) (vi) of R.A. No. 7160;

WHEREAS, the projects: Procurement of Cemetery Lot and the Construction of Mapandan Municipal Cemetery Extension 2 were included in the approved Supplemental Annual Investment Program No. 4, CY 2021 of LGU-Mapandan;

WHEREAS, the LGU-Mapandan shall observe that the subject ordinance must be pursued in line with the provisions of the Local Government Code of 1991 which mandates that every loan application must comply with the requirements of the Department of Finance, the Bureau of Local Government Finance Circular No. 1-2012 and the Bangko Sentral ng Pilipinas Circular No. 769, S-2012;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 6, S-2021 of the Sangguniang Bayan of Mapandan, Pangasinan, entitled “An Ordinance authorizing the proposed borrowing of the Municipality of Mapandan, Province of Pangasinan, in the amount of Seventy Eight Million Pesos (P78,000,000.00) approving the terms and conditions and other terms and conditions of the loan” as within the conferred powers of the Sangguniang Bayan to enact;
