APPROVING RESOLUTION NO. 18-114 (A) OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 11 FOR CALENDAR YEAR 2018 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN”

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 18-114 (A) to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos, Pangasinan has prepared the city’s Supplemental Investment Program No. 11 for CY 2018. This was endorsed thru CDC Resolution No. 17-18 dated November 28, 2018 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 18-114 (A) dated December 2, 2018;

WHEREAS, the Supplemental Investment Program covers the “Rehabilitation of the New Public Market (Fish Section)” and “Rehabilitation of the New Public Market Drainage Canal Cover (Fish and Meat Section)” of the LGU amounting to a total of P1,026,382.57. Said projects are part of the details
