#### PROVINCIAL RESOLUTION NO. 274-2020

INVITING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MARCH 9, 2020 REGULAR SESSION TO SHED LIGHT ON THE PROACTIVE MEASURES BEING UNDERTAKEN BY THE AGENCY TO PRESERVE AND PROTECT THE ENVIRONMENTAL AREAS OF THE DAANG KALIKASAN ROAD

**WHEREAS**, the Daang Kalikasan Road Project is a 54-kilometer roadline that would connect Region I on the part of the Province of Pangasinan to Region III on the part of the Province of Zambales;

WHEREAS, the Daang Kalikasan Road is a joint project of the Department of Public Works and Highways (DPWH), Department of Environment and Natural Resources (DENR) and the Department of Tourism (DOT) designed to preserve the natural habitat of the area;

**WHEREAS**, the Daang Kalikasan Road is surrounded by a rich and beautiful landscape of rolling hills, forests and other resources that need to be protected in order to preserve its natural grandeur;

WHEREAS, likewise, it is important to safeguard the public lands in the areas traversed by the Daang Kalikasan Road from getting occupied and claimed by unscrupulous individuals;

**WHEREAS**, the DENR, which plays an important role in the preservation and protection of the environment is the proper agency that can shed light on the matter;
