**PROVINCIAL RESOLUTION NO. 276-2020**

**REQUESTING CONGRESS TO CLASSIFY THE MANGATAREM-STA CRUZ ROADLINE AS A NATIONAL ROAD AND TO OFFICIAL NAME THE SAME AS DAANG KALIKASAN ROAD**

**WHEREAS**, the Mangatarem-Sta Cruz Roadline is a 54-kilometer stretch roadline that will soon link Pangasinan Province to Zambales Province;

**WHEREAS**, at present, the said roadline is considered as an unclassified road by the Department of Public Works and Highways and is popularly known as Daang Kalikasan Road;

**WHEREAS**, the construction of the Mangatarem-Sta Cruz Roadline is nearing its completion and improvement plans for the scenic Pangasinan road are soon to be implemented in the area;

**WHEREAS**, the proponent of the Mangatarem-Sta. Cruz Roadline Project, former Congressman of the 2<sup>nd</sup> District of Pangasinan and now the incumbent Municipal Mayor of Lingayen, Pangasinan has sought the help of the Sangguniang Panlalawigan during the Question Hour held on its March 2, 2020 Regular Session for the classification of the same as a national road and its official naming as Daang Kalikasan Road;

**WHEREAS**, its name per se, Daang Kalikasan Road accurately represents the place of its location where rolling hills, forests and other natural resources flourish;

**WHEREAS**, it is important for the road to have an official name to be approved by higher authorities in order to be clearly and easily identified and located by the general public;


**WHEREAS**, likewise, its classification as a national road would facilitate the allocation of funds by the national government for its maintenance and improvement;
