BARBARA, PANGASINAN, ENTITLED “CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 12, SERIES OF 2021 ENTITLED “ADOPTION OF RESOLUTION ENDORSING THE REVISED MUNICIPAL DEVELOPMENT PLAN FUNDED BY TWENTY PERCENT (20% ECONOMIC DEVELOPMENT FUND OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2022 AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL”


