RESOLUTION NO. 277-2021

APPROVING RESOLUTION NO. 103-2020 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 103-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Urbiztondo, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Local Development Council to the Sangguniang Bayan on October 6, 2020 through MDC Resolution No. 04, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Urbiztondo, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction programs, projects, and activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Gender and Development Plan, g) Annual Procurement Plan, and h) list of PPAs for the Local Culture and the Arts Action Plan, Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities, Local Nutrition Action Plan and PPAs to combat AIDS and to address the problems on illegal drugs;

WHEREAS, the proposed AIP of Urbiztondo for CY 2021 has an investment requirement of P1,291,409,663.70. Out of which, P165,604,066.61 will be funded from the proposed 2021 Annual Budget of the LGU, which was passed and approved by their Sangguniang Bayan on October 19, 2019 through Appropriation Ordinance No. 4-2020. The remaining P1,125,805,597.09 is proposed to be funded from the LGU's loan proceeds from the Land Bank of the Philippines and external funds sources/national government agencies;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P153,596,917.00), which is equivalent to P30,719,383.40 is allocated for development projects. These development programs/projects conform to the Joint DBM-DOF-DILG Memorandum Circular No. 2017-1, dated February 22, 2017 (*Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects*);

WHEREAS, the Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P8,575,345.85), is in accordance to Section 21 of RA 10121. The programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P6,002,742.09 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (*Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund*) and Local Budget Circular NO. 124, dated March 26, 2020 of the Department of Budget and Management (*Policy Guidelines on the Provision of Funds by Local Government Units for Programs, Projects and Activities to Address the Corona Virus Disease 2019 Situation*);

WHEREAS, the LGU of Urbiztondo had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and were found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;


