DECLARING MUNICIPAL ORDINANCE NO. 103, S-2018 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE MORAL RECOVERY PROGRAM (MRP) IN THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 103, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;
