**RESOLUTION NO. 28-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 103, S-2018 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE MORAL RECOVERY PROGRAM (MRP) IN THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 103, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 16 of RA 7160; Article II, Section 21 of the Philippine Constitution; Proclamation No. 62 dated September 30, 1992 and Executive Order No. 319;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;


