**PROVINCIAL RESOLUTION NO. 282-2022**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO GRANT FINANCIAL ASSISTANCE AMOUNTING TO ONE MILLION FIVE HUNDRED PESOS (P1.5 MILLION) FOR THE SETTLEMENT OF THE PANGASINAN-LAOAC DAIRY FARM'S ELECTRICITY/POWER BILL**


