RESOLUTION NO. 288-2021

APPROVING RESOLUTION NO. 281, S-2020 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED "APPROVING THE PROPOSED ANNUAL INVESTMENT PROGRAM (AIP), CALENDAR YEAR (CY) 2021 OF THE LOCAL GOVERNMENT OF UMINGAN, PANGASINAN WITH THE TOTAL AMOUNT OF TWO HUNDRED FORTY TWO MILLION EIGHT HUNDRED TWENTY SEVEN THOUSAND THREE HUNDRED TEN PESOS (P242,827,310.00)

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Resolution No. 281, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Umingan, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2021, and endorsed through MDC Resolution No. 7, S-2020 dated November 4, 2020 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Umingan, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and

other services sectors and covers a) all the regular budgetary items for the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Local Climate Change Action Plan, and 2) Peace and Order Plan, Cultural Plan, Nutrition Program, list of programs/projects for the Local Council for the Protection of Children and PPAs for Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP of Umingan has a total investment requirement amounting to P242,827,310.00 which is supported by the CY 2021 Annual Budget of Umingan, Pangasinan which was enacted on December 2, 2020 by the Sangguniang Bayan through Appropriation Ordinance No. 6, S-2020;

WHEREAS, the development fund amounting to P44,033,782.00 which is allocated for development projects is twenty percent (20%) of the municipality's IRA (P220,168,910.00) for CY 2021. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 (Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects); However, the municipality shall specify the details of the project, Construction, Improvement, Rehabilitation of Development Projects to Barangays;

WHEREAS, the programs, projects and activities identified to be funded by the 5% LDRRM Fund of the municipality amounting to P11,757,866.00 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan of the municipality shall be submitted to the Office of Civil Defense (OCD) for review as provided under Item No. 2.2.12 of the Department of Budget and Management Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the AIP 2021 of the LGU Umingan also include PPAs to be funded by other/external sources (LBP Loan, NGAs, Congress and Office of the President in the amount of P1,841,126,000.00;

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
