APPROVING RESOLUTION NO. 226, S-2019 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PANGASINAN FUNDED UNDER ANNUAL BUDGET CY 2020 AMOUNTING TO TWENTY MILLION ONE HUNDRED THOUSAND ONE HUNDRED SIXTEEN PESOS AND 60/100 (P20,100,116.60)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 226, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Bautista, Pangasinan has formulated the municipality's Annual Investment Program for CY 2020 and endorsed thru MDC Resolution No. 05, S-2019 dated September 24, 2019 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 226, S-2019 dated October 21, 2019. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01

dated July 23, 2015 as to format and content. The AIP of Bautista, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes as an integral part the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan, Nutrition Plan, Annual Procurement Plan and Annual Cultural Development Plan and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP is supported by CY 2020 Annual Budget of Bautista, Pangasinan which was passed and approved by their Sangguniang Bayan on November 4, 2019 through Appropriation Ordinance No. 3, S-2019; amounting to P104,749,570.19;

WHEREAS, the development fund amounting to P20,100,116.60 which is allocated for development projects is 20% of the municipality's IRA (P100,500,583.00) for CY 2020. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the identified development programs/projects to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P5,081,852.65 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan of the municipality was reviewed and a certification was issued by the Office of the Civil Defense dated November 4, 2019;

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the LGU of Bautista has also included in their AIP the programs, projects and activities to be funded by the national government agencies-under Assistance to Municipality Program;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
