APPROVING RESOLUTION NO. 2020-222 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 5<sup>TH</sup> SUPPLEMENTAL ANNUAL INVESTMENT PLAN-CY 2020 OF THE MUNICIPAL GOVERNMENT OF SISON, PANGASINAN EMBODYING THE PROGRAMS AND PROJECTS TO BE FUNDED FROM THE 90% SHARE OF THE MUNICIPALITY FROM COLLECTIONS OF EXCISE TAX ON BURLEY AND NATIVE TOBACCO EXCISE TAX PURSUANT TO R.A. NO. 8240, AS AMENDED BY R.A. 10351"

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2020-222 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sison, Pangasinan has formulated the municipality's 5<sup>th</sup> Supplemental Annual Investment Plan covering projects to be funded from LGU's share from FY 2017 collection of Burley and Native Tobacco Excise Tax in the amount of P12,476,265.00. This was endorsed thru MDC Resolution No. 07-2020 dated November 16, 2020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the identified projects to be funded from FY 2017 collection of Burley and Native Tobacco Excise Tax are new projects and not included in the municipality's 2020 approved Annual and Supplemental Investment Programs;
