## **RESOLUTION NO. 29-2022**

APPROVING RESOLUTION NO. 71-2021 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its SB Resolution No. 71-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS,** the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

**WHEREAS,** the Local Development Council of Urbiztondo, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on November 18, 2021 through MDC Resolution No. 03, series of 2021;

**WHEREAS**, the said Supplemental Investment Program of the municipality covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices and implementation of disaster risk reduction programs and development projects of the municipality;
