DECLARING SB RESOLUTION NO. 056-2018 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE COMPREHENSIVE LAND USE PLAN (CLUP) FOR CALENDAR YEAR 2018 TO 2028 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 056-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (vii) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Comprehensive Land Use Plan (CLUP) of Malasiqui, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;

WHEREAS, the CLUP of Malasiqui, Pangasinan is found to be in conformity with the existing Land Use Planning, Guidelines, Laws and Regulations and other development plans of the Province;

WHEREAS, the Municipality of Malasiqui, Pangasinan shall publish the subject resolution pursuant to Section 59 of RA 7160 and per CLUP Guidebook (A Guide to Comprehensive Land Use Plan Preparation, Volume 1, 2013);

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Angel M. Baniqued, Jr. and Generoso D. Tulagan, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare SB Resolution No. 056-2018 of the Sangguniang Bayan of **Malasiqui**, Pangasinan, entitled "Approving and adopting the Comprehensive Land Use Plan (CLUP) for Calendar Year 2018 to 2028 of the Municipality of Malasiqui, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
