PROVINCIAL RESOLUTION NO. 292-2021

INVITING ANEW THE LAND TRANSPORTATION, AND FRANCHISING REGULATORY BOARD REGIONAL OFFICE FOR A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MARCH 8, 2021 REGULAR (WEB-BASED/ONLINE) SESSION TO SHED LIGHT ON THE POSSIBILITY OF THE REOPENING OF TRANSPORTATION SERVICES PARTICULARLY INTERPROVINCIAL BUSES IN PANGASINAN, IN AID OF LEGISLATION

WHEREAS, Provincial Resolution No. 279-2021, dated February 22, 2021, called for the invitation of the Land Transportation, Franchising and Regulatory Board (LTFRB) to a Question Hour of the Sangguniang Panlalawigan on its March 1, 2021 Regular (Physical) Session to shed light on the possibility of the reopening of transportation services particularly interprovincial buses in Pangasinan;

WHEREAS, relative thereto, a Question Hour was scheduled on March 1, 2021, unfortunately however, the Land Transportation, Franchising and Regulatory Board Regional Director was unable to attend the same due to an emergency meeting at Ilocos Norte on the same matter being requested by the Provincial Board of allowing the relaxation of provincial buses;

WHEREAS, it is for this reason that the Sangguniang Panlalawigan opted again to invite the Land Transportation, Franchising and Regulatory Board on its next regular session;




