**APPROVING RESOLUTION NO. 108, S-2019 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE RESOLUTION NO. 07, SERIES OF 2019 OF THE MUNICIPAL DEVELOPMENT COUNCIL, CALASIAO, PANGASINAN ENTITLED, "RESOLUTION RECOMMENDING APPROVAL OF THE REALIGNMENT/REVERSION OF THE AMOUNT OF FOUR MILLION EIGHT HUNDRED THOUSAND PESOS (P4,800,000.00) FROM UNUSED PORTION OF THE TWENTY PERCENT (20%) DEVELOPMENT FUND OF THE 2019 ANNUAL INVESTMENT PROGRAM FOR PURPOSES OTHER THAN THOSE STIPULATED"**

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 108, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Calasiao, Pangasinan has proposed for the realignment of funds from the unused portion of the 20% development fund CY 2019, amounting to P4,800,000.00. This was endorsed thru MDC Resolution No. 07, S-2019 dated November 11, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said realignment through Sangguniang Bayan Resolution No. 108, S-2019 dated November 18, 2019;


