THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on August 22, 1988, at Lingayen, Pangasinan, the following Ordinance was approved:

PROVINCIAL ORDINANCE NO. 3

AN ORDINANCE CREATING SITIO SINABAAN IN SAN VICENTE, ALCALA, PANGASINAN, AS A NEW, DISTINCT, SEPARATE AND INDEPENDENT BARANGAY TO BE NAMED "BARANGAY SINABAAN", ALCALA, PANGASINAN

WHEREAS, this Body is in receipt of Resolution No. 24, s-1988, of the Sangguniang Bayan of Alcala, Pangasinan, requesting this Body to favorably act on the clamor of the residents, to create a new, distinct, separate and independent barangay to be named "Barangay Sinabaan", pursuant to Sections 82 and 83 of the Local Government Code;

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code in the creation of new barangays, all the requirements therein are satisfactorily met;

WHEREAS, the residents and local leaders therein are of the firm belief that the creation would greatly hasten the development of this barangay;

NOW, THEREFORE, on motion of Board Member Dionisio C. Antiniw, duly seconded by Board Member Francisco F. Baraan, III, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to create, as it hereby creates, the present Sitio Sinabaan of Barangay San Vicente, Alcala, Pangasinan into a new, distinct, separate and independent barangay to be named "Barangay Sibabaan";

RESOLVED, FURTHER, to request the COMELEC to schedule the holding of plebiscite in this newly created Barangay Sinabaan within 45 days from the approval of this Ordinance;

RESOLVED, FURTHERMORE, that the Provincial Assessor, in coordination with other agencies determine the official boundaries of this newly created barangay;

RESOLVED, FINALLY, that copies of this Ordinance be furnished the Provincial Assessor, Provincial Treasurer, Provincial Auditor, Provincial Engineer, the DLG, DFWH, Bureau of Lands, PC-INP, COMELEC and DECS for their information and guidance.
