PROVINCIAL RESOLUTION NO. 3-2019

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO, III, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE EUROLINK NETWORK INTERNATIONAL CORPORATION, A DULY ACCREDITED HEALTH INFORMATION TECHNOLOGY PROVIDER (HITP), FOR THE PROVISION OF ELECTRONIC CLAIMS (E-CLAIMS) SYSTEM TO THE HEALTH CARE INSTITUTIONS OF THE PROVINCE OF PANGASINAN FOR THE PURPOSE OF ITS RENEWAL

WHEREAS, Eurolink is an independent contractor and third party Electronic Claims (eCLAIMS) Health Information Technology Provider (HITP), a duly authorized, accredited and licensed by the Philippine Health Insurance Corporation (PHILHEALTH) to engage in PHILHEALTH benefit claims transactions management with LGU Pangasinan for the purpose of providing access to PHILHEALTH's eCLAIMS utility framework for the latter through Eurolink's "Easy Claims" Application Software;

WHEREAS, PhilHealth issued Circular No. 2016-0016 mandates all health care facilities for the full implementation of the Electronic Claims System;

WHEREAS, the Province of Pangasinan has engaged the services of Eurolink Network International Corporation for the implementation of the said program;

WHEREAS, the Provincial Health Office has reported that for the period of January to earlier part of November 2018, the Province of Pangasinan, through its fourteen (14) hospitals, was able to reimburse a total of P845,975,632.00 from Philhealth using the Eurolink eCLAIMS System;

WHEREAS, the Memorandum of Agreement between the Province of Pangasinan and the Eurolink Network International Corporation has expired on December 31, 2018 and there is a need to renew the same;


WHEREAS, for the above purpose, there is a need for a new a Memorandum of Agreement to be entered into and signed between the Province of Pangasinan, represented by Honorable Governor, Amado I. Espino III; and the Eurolink Network International Corporation, represented by its authorized representatives, Ms. Abigail Ong and Mr. Rubencito Lao, in order to substantially expedite the Philhealth claims of the Province;

WHEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Honorable Governor Amado I. Espino, III, to enter into a Memorandum of Agreement with the Eurolink Network International Corporation, a duly accredited Health Information Technology Provider (HITP), for the provision of Electronic Claims (E-Claims) System to the health care institutions of the Province of Pangasinan for the purpose of its renewal;

RESOLVED, FURTHER, that copies of this resolution be furnished to Honorable Governor Amado I. Espino III, Provincial Health Office, all Chiefs of Hospitals, and all other concerned government offices, for their information and guidance.
