**APPROVING RESOLUTION NO. 132A, S-2018 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 5 FOR CY-2018 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P2,634,395.07”**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 132A, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Fabian, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program No. 5 for CY 2018. This was endorsed by the Council thru MDC Resolution No. 06, S-2018 dated December 7, 2018 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 132A, S-2018 dated December 10, 2018;

**WHEREAS**, the Supplemental Investment Program of the municipality which has a total funding requirement of P2,634,395.07, covers augmentation funds for the MOOE of the LDRRM and GAD projects/activities and other development priorities of the LGU;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


