**RESOLUTION NO. 302-2022**

**APPROVING RESOLUTION NO. 2021-231 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2022 OF THE CITY OF ALAMINOS, PANGASINAN”**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2021-231 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Alaminos City, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2021. This was endorsed by the City Development Council to the Sangguniang Panlungsod on September 30, 2021 thru CDC Resolution No. 03, Series of 2021 and was favorably acted upon by the Sangguniang Panlungsod on December 7, 2021 thru SP Resolution No. 2021-231.

2. The Annual Investment Program of the city is in accordance with the Budget Operations Manual (BOM) for Local Government Units – 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 2007 dated 08 March 2007 and DBM-CCC-DILG JMC No. 2014-dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-1 – dated July 23, 2015 as to format and contents. The AIP of Alaminos City, Pangasinan was formulated following the prescribed AIP Summary Form and covers a) all the regular budgetary requirements for the operation of the different municipal offices broken down into PS, MOOE and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) disaster risk reduction programs, projects and activities, d) City Climate Change Action Plan, e) Peace and Order and Public Safety Plan, f) Local Nutrition Action Plan, g) Gender and Development Plan, h) Annual Cultural Development Plan, i) Local Youth Development Plan; j) Annual Procurement Plan; and k) programs, projects and activities (PPAs) for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome and PPAs to address Problems on Illegal Drugs.
3. The proposed AIP of Alaminos City for CY 2022 has an investment requirement of P936,593,136.00. Funding support for the implementation of which is embodied in their 2022 proposed Annual Budget, which was enacted by their Sangguniang Panlungsod on December 7, 2021 thru Appropriation Ordinance No. 2021-06 and approved by the City Mayor on December 23, 2021.
4. This AIP is in accordance with Section 287 of LGC of 1991. Twenty percent (20%) of the LGU's NTA (P854,385,454.00), which is equivalent to P170,877,091.00 is allocated for development projects based on Joint DBM-DOF-DILG Memorandum Circular No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects).
5. The Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P46,829,657.00), is in conformity to Section 21 of RA 10121. The programs, projects and activities of the 70% of the 5% LDRRMF in the amount of P32,780,759.90 were based on NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government (Allocation and Utilization of the Local Disaster Risk Reduction and Management

Fund). It is respectfully suggested that the DRRM Plan shall be submitted to the Office of Civil Defense (OCD) for review as per Local Budget Memorandum No. 77, dated May 15, 2018 and Local Budget Memorandum No. 82 dated June 14, 2021.

6. The LGU of Alaminos City had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015.
7. The Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the DILG Provincial Office and were found to be fully compliant in form and in contents with the provisions of the Joint Memo-Circular (DBM, PCW, DILG & NEDA) No. 2016-01: Amendments to JMC 2013-01 or the Guidelines on the Localization of the Magna Carta of Women.
8. As to the Devolution Transition Plan (2022-2024) as one of the supporting documents of this AIP, it is respectfully recommended that the LGU shall strictly observe Item 3.2 of DBM Local Budget Memorandum No. 82-A dated August 19, 2021 which states that “Considering the timeline on the preparation and submission of the LGU DTP under DBM-DILG JMC No. 2021-1, the LCE shall not be mandatorily required to include the LGU DTP as part of the supporting documents of the AIP and the LEP to be submitted to the local sanggunian for budget authorization purposes. However, in case the LGU has already prepared and approved its LGU-DTP, the same may be part of the supporting documents of the AIP and LEP to be submitted by the LCE to the local sanggunian”. Further, Item 6.3.2 of the DBM-DILG Joint Memorandum Circular No. 2021-1 dated August 11, 2021 advised LGUs to “integrate fully assumed responsibilities in the updating of their local development plans, sectoral thematic plans and investment programs”.
9. The appropriation for the grant of step increment to the Liga President is hereby not authorized since Elective Barangay Officials are excluded in the coverage of the CSC-DBM Joint Circular No. 01, S-2016 (Rules and Regulations on the Grant of Step Increment to Elective Officials Based on Length of Service.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Alaminos, Pangasinan;


