PROVINCIAL RESOLUTION NO. 305-2019

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO, III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL ECONOMIC AND DEVELOPMENT AUTHORITY REGIONAL OFFICE I FOR THE ESTABLISHMENT OF A SATELLITE REGIONAL DEVELOPMENT KNOWLEDGE CENTER AT THE PROVINCIAL PLANNING AND DEVELOPMENT OFFICE IN THE PROVINCE OF PANGASINAN

WHEREAS, the Regional Development Knowledge Center (RDKC) is a repository and access point of National Economic and Development Authority Regional Office's (NEDA-RO1) acquired and generated knowledge assets on regional development concerns, which caters to the data/information needs of programme implementers, policy-makers, students and development advocates to promote knowledge utilization for regional development and productivity;

WHEREAS, NEDA-RO1 partners with State Universities and Colleges (SUCs) and local government units (LGUs) with libraries for the hosting and expansion of the RDKC to enjoin more stakeholders to access and use the knowledge materials;

WHEREAS, the Provincial Government of Pangasinan has intended to establish such center to further enhance the development advocacies in the Province, and a Memorandum of Agreement is needed before its establishment;

WHEREAS, the Memorandum of Agreement will serve as a vehicle for collaboration efforts between the Province of Pangasinan and the NEDA Regional Office to further boost the statistical development in the Province;


