RESOLUTION NO. 309-2019

DECLARING ORDINANCE NO. 2018-13 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS CITY, PANGASINAN, ENTITLED "AN ORDINANCE REVISING CITY ORDINANCE NO. 2006-09, ENTITLED "AN ORDINANCE ENACTING GENDER AND DEVELOPMENT (GAD) CODE OF THE CITY OF ALAMINOS AND MANDATING THE IMPLEMENTATION OF A COMPREHENSIVE AND SUSTAINABLE GAD PROGRAM" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2018-13 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 17 (a) (iv) (4) of RA 7160; the Gender and Development Code of the Philippines; RA 7192 (An Act Promulgating the Integration of Women as Full and Equal Partners of Men in Development and Nation Building and For Other Purposes) and RA 9710 (Magna Carta of Women);

WHEREAS, however, the Sangguniang Panlungsod shall consider the observations of the Provincial Legal Officer stated in her opinion dated April 1, 2019 (which were not yet addressed by the Sanggunian), as attached in this Resolution;


WHEREAS, subject ordinance shall take effect after the Sangguniang Panlungsod has complied with the requirements of posting and publication pursuant to RA 7160;
