RESOLUTION NO. 31-2020

DECLARING MUNICIPAL ORDINANCE NO. 19-008 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING FRANCHISE TO MR. MODESTO B. MELCHOR TO OPERATE AND MAINTAIN A COCKPIT ARENA IN THE MUNICIPALITY OF LAOAC, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 19-008 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (3) (v), (4) (viii) of RA 7160;

WHEREAS, the Sangguniang Bayan shall comply with the observation that the subject area of cockpit arena is outside the prohibited area as provided for in Presidential Decree No. 449 otherwise known as The Cockfighting Law of 1924 and Presidential Decree No. 1310 (amending PD No. 449);

WHEREAS, subject ordinance shall take effect after the requirements set forth in Sections 187 and 188 of RA 7160 have been complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
