RESOLUTION NO. 31-2021

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2020 OF THE CITY OF URDANETA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P51,157,224.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2020 involving total appropriations of **P51,157,224.00** which was approved on April 4, 2020 through Ordinance No. 16, S-2019-22;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. The utilization of all appropriations funded under Bayanihan Grant to Cities and Municipalities (BGCM), as well as compliance with the reportorial requirements, shall be subject to the provisions of Local Budget Circular No. 125 dated April 7, 2020; and

3. The grant of Hazard Pay to government personnel who physically reported for work during the period of implementation of an Enhanced Community Quarantine relative to the COVID-19 Outbreak shall be in accordance with the provisions of Administrative Order No. 26 by the President of the Philippines dated March 23, 2020 and Budget Circular No. 2020-1 dated March 24, 2020.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 2 for Calendar Year 2020 of the City of Urdaneta, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the City Government of Urdaneta;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Panlungsod of Urdaneta, Pangasinan, for its information and guidance.
