APPROVING RESOLUTION NO. 2018-159 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2018 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 (SAIP NO. 04) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO EIGHTEEN MILLION FORTY-SEVEN THOUSAND NINE HUNDRED NINETY-NINE PESOS AND TWO CENTAVOS (P18,047,999.02)"

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2018-159 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The City Development Council of Alaminos, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2018. This was endorsed to the Sangguniang Panlungsod for approval on November 21, 2018 thru CDC Executive Committee Resolution No. 03, S-2018 and was favorably acted upon by the Sangguniang Panlungsod on November 26, 2018 thru SP Resolution No. 2018-159;

WHEREAS, the Supplemental Investment Program No. 4 of the city covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of city government offices and the implementation of disaster risk reduction programs;

WHEREAS, the funding requirement for the full implementation of this Supplemental Investment Program No. 4 in the amount of P18,047,999.02 is embodied in LGU's proposed Supplemental Budget No. 03 which was approved and enacted by their Sangguniang Panlungsod on December 19, 2018 thru Appropriation Ordinance No. 2018-04 and approved by the City Mayor on January 16, 2019;
