APPROVING SB RESOLUTION NO. 207-2021 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 FOR CY 2021 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SP Resolution No. 207-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Mangatarem, Pangasinan had identified items in this Supplemental Investment Program No. 5 CY 2021 which was endorsed to the Sangguniang Bayan for approval on December 16, 2021 through MDC Executive Committee Resolution No. 07, S-2021;

WHEREAS, Supplemental Investment Program No. 5 covers the project Construction of Drainage Canal at Barangay Torre St., proposed to be funded from the Local Government Support Fund (LGSF)-Financial Assistance to Local Government Units in the 2021 General Appropriations Act, Republic Act No. 11518 in the amount of P9,000,000.00;
