WHEREAS, the Supplemental Investment Program No. 1 shall cover the fund augmentation for the Personal Services and Maintenance and Other Operating Expenses of all provincial offices and hospitals and implementation of development project, disaster risk reduction projects/activities and other programs of the Province;

WHEREAS, the **P155,233,026.99** total investment requirement of Supplemental Investment Program No. 1 is fully supported by Supplemental Budget No. 4 which shall be sourced from the additional estimated income and reversion of outstanding payables CY 2017;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


