**WHEREAS**, the City Development Council – Executive Committee of San Carlos City, Pangasinan proposed to the Sangguniang Panlungsod the realignment of the sum of P6,300,000.00 from the balances of 5% Local Disaster Risk Reduction and Management Fund of the LGU. 
