DECLARING MUNICIPAL ORDINANCE NO. 2-2019 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF LABOR AND EMPLOYMENT OFFICER III, A PLANTILLA POSITION UNDER THE OFFICE OF THE MUNICIPAL MAYOR OF ANDA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 2-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;


