APPROVING RESOLUTION NO. 212-111819 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE SECOND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2019 FUNDED BY UNAPPROPRIATED SURPLUS AND SAVINGS FROM PREVIOUS YEAR AND REVERSION OF APPROPRIATION OF UNFILLED POSITIONS OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 212-111819 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated the municipality’s 2nd Supplemental Investment Program for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 02, S-2019 dated October 29, 2019. The Sangguniang Bayan approved the said 2nd Supplemental Investment Program on November 18, 2019 thru Resolution No. 212-111819. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the 2nd Supplemental Investment Program of the municipality with an investment requirement of P6,287,069.20 covers the fund augmentation for MOOE of some offices and disaster risk reduction and management activities of the municipality;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
