**PROVINCIAL RESOLUTION NO. 321-2020**

**WAIVING THE RIGHTS OF THE PROVINCIAL  
GOVERNMENT OF PANGASINAN TO CONFIDENTIALITY  
OF INFORMATION**

**WHEREAS**, the Provincial Government of Pangasinan is entering into a loan agreement with the Land Bank of the Philippines to finance socio-economic and infrastructure projects;

**WHEREAS**, one of the necessary documents prior to the release of the loan is for the Provincial Government of Pangasinan to waive the rights to confidentiality of information;

**WHEREAS**, the Province of Pangasinan is authorizing the Land Bank of the Philippines to disclose to the Bangko Sentral ng Pilipinas all information pertaining to the deposits, investments, loans or other transactions including history and status of dealings with said bank and for the BSP to make all inquiries as may be necessary pertaining thereto;

**WHEREAS**, the Province of Pangasinan authorizes the BSP to disclose and share any such information furnished or obtained from the said bank to the Department of Finance in relation to the performance by the said Department of its functions;

**WHEREAS**, any resolution or part thereof, inconsistent with this resolution is hereby repealed or amended accordingly;

**WHEREAS**, this resolution shall take effect upon its compliance with all procedures required under Republic Act No. 7160 of a resolution for its validity including the affixation of signatures of Sangguniang Panlalawigan Members, in concurrence thereto, composing at least a majority thereof, out of the total of 15 members and the Presiding Officer on all the pages of this resolution;




