## **RESOLUTION NO. 322-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 3, S-2018 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED “AN ORDINANCE REPEALING SECTION 5J.01. ARTICLE J CHAPTER V OF THE REVISED REVENUE CODE OF DASOL, PANGASINAN, AS AMENDED BY MUNICIPAL ORDINANCE NO. 04, S-2016” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Dasol, Pangasinan submitted its Municipal Ordinance No. 3, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the power of the Sangguniang Bayan to enact ordinances and approve resolutions carries with the power to amend, revoke, modify, or repeal the same;

**WHEREAS**, the enactment of the amended ordinance is justified pursuant to Sections 447 (a) (3) (i) of RA 7160;

**WHEREAS**, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer and the Provincial Treasurer stated in their opinions dated March 28, 2019 and April 22, 2019, respectively, as attached in this Resolution;
