**PROVINCIAL RESOLUTION NO. 322-2020**

**EXTENDING THE PAYMENT OF CURRENT REAL PROPERTY TAXES WITHIN THE TERRITORIAL JURISDICTION OF THE PROVINCE OF PANGASINAN FOR THE AVAILMENT OF THE TWENTY PERCENT (20%) DISCOUNT FROM MARCH 31, 2020 TO MAY 31, 2020**

**WHEREAS**, Section 2 of Provincial Ordinance No. 166-2012 of the Sangguniang Panlalawigan dated November 12, 2012 on Tax Discount on Advance Payment provides that “if the basic real property and additional Special Education Fund (SEF) tax for the current year are paid in full on or before March 31 of the tax year, then a twenty percent (20%) discount shall be granted to the taxpayer”;

**WHEREAS**, the Province of Pangasinan is now adopting measures to implement guidelines for the imposition of the Enhanced Community Quarantine over the entire Luzon and for the management of COVID-19;

**WHEREAS**, there is a need to lighten the plight of real property owners in the Province of Pangasinan in the payment of current real property taxes in view of the alarming situation brought about by COVID-19 and in compliance with the directives on Enhanced Community Quarantine;

**WHEREAS**, the Sangguniang Panlalawigan finds it meritorious and proper to extend the deadline on the availment of the 20% discount for the payment of current real property taxes to give leeway to taxpayers to abide by the directives of higher authorities toward enhanced community quarantine;

**NOW, THEREFORE**, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was -


