PROVINCIAL RESOLUTION NO. 324-2021

**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 2 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2021**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 2 of the Province of Pangasinan as endorsed by the Provincial Development Council thru PDC Execom Resolution No. 03-21;

WHEREAS, Supplemental Investment Program No. 2 contains various programs, projects and activities that are not included in the approved 2021 Annual/Supplemental Investment Programs of Pangasinan;

WHEREAS, the Supplemental Investment Program No. 2 embodies the programs supportive of education services proposed to be funded from the Special Education Fund 2021 as well as the various projects to be funded from the share of the Province from the Energy Regulation (ER) 1-94 of the 1000MW and 200MW Sual Coal-Fired Thermal Power Plant and the San Roque Power Corporation;

WHEREAS, also included are the Laoac-Pangasinan Dairy Farm Partnership Project, Moral Recovery Program as well as the details of infrastructure projects, all funded from the current appropriations in the Annual Budget 2021;

WHEREAS, the said Supplemental Investment Program also includes the Upgrading of Dagupan-Calasiao via Malued-Lasip Road in Calasiao and the Upgrading of San Jacinto-Pozzorubio Road in San Jacinto and Pozzorubio, all in Pangasinan, which are enrolled for funding from the Local Government Support Fund – Financial Assistance (LGSF-FA) to Local Government Units in Republic Act No. 11518 or the 2021 General Appropriations Act;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


WHEREAS, after careful study of the said Program, this august Body finds it to be in order;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


