PROVINCIAL RESOLUTION NO. 325-2021

APPROVING THE INCLUSION OF TWO (2) ROAD PROJECTS, NAMELY: UPGRADING OF SAN JACINTO-POZORRUBIO ROAD IN SAN JACINTO AND POZORRUBIO AND UPGRADING OF DAGUPAN-CALASIAO VIA MALUED-LASIP ROAD IN CALASIAO, ALL IN PANGASINAN, IN THE PROVINCIAL DEVELOPMENT INVESTMENT PROGRAM 2018-2027 OF THE PROVINCE OF PANGASINAN

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the inclusion of two (2) road projects, namely: Upgrading of San Jacinto-Pozorrubio Road in San Jacinto and Pozorrubio and Upgrading of Dagupan-Calasiao via Malued-Lasip Road in Calasiao, all in Pangasinan, in the Provincial Development Investment Program 2018-2027 of the Province of Pangasinan as indorsed by the Provincial Development Council through PDC Execom Resolution No. 07-21;

WHEREAS, the PDIP is a financing plan and investment schedule during a 10-year planning period, which ensures that limited resources of the Province are allocated and utilized properly for the implementation of priority programs and projects geared towards achieving local and national roads, objectives and priorities;

WHEREAS, there is a need to update the program to include the two (2) road projects of the Province, namely: Upgrading of San Jacinto-Pozorrubio Road in San Jacinto and Pozorrubio and Upgrading of Dagupan-Calasiao via Malued-Lasip Road in Calasiao, Pangasinan;

WHEREAS, the said road projects are proposed for funding by the Local Government Support Fund- Financial Assistance (LGSF-FA) to Local Government Units in Republic Act No. 11518 or the 2021 General Appropriations Act;

WHEREAS, the two (2) infrastructure projects of the Province and its corresponding funding are as follows:

NAME OF PROJECT	LENGTH (km.)	TOTAL PROJECT COST
1. Upgrading of San Jacinto-Pozorrubio Road, SAN JACINTO	5.935	P125,000,000.00
2. Upgrading of Dagupan-Calasiao via Malued-Lasip Road, CALASIAO	5.105	P125,000,000.00

WHEREAS, to avail of the fund, one of the requirements is the inclusion of the projects in the Local Development Investment Program and in the Annual Investment Program of the LGU as specified in Local Budget Circular No. 131 dated January 8, 2021 of the Department of Budget and Management;

WHEREAS, the inclusion of the projects to the Provincial Development Investment Program is geared toward the socio-economic development goals and thrusts of the Province;

WHEREFORE, in view of the foregoing, on motion of SP Members Angel M. Baniqued, Jr. and Salvador S. Perez, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to approve, as it is hereby approved, the inclusion of two (2) road projects, namely: Upgrading of San Jacinto-Pozorrubio Road in San Jacinto and Pozorrubio and Upgrading of Dagupan-Calasiao via Malued-Lasip Road in Calasiao, all in Pangasinan, in the Provincial Development Investment Program 2018-2027 of the Province of Pangasinan;
