**RESOLUTION NO. 333-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 7, S-2018 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE AUTHORIZING THE LOCAL GOVERNMENT UNIT OF BINMALEY THRU ITS MUNICIPAL MAYOR HONORABLE SIMPLICIO L. ROSARIO FOR A LOAN BORROWING IN THE AMOUNT OF ONE HUNDRED THIRTY MILLION PESOS (P130,000,000.00) TO FINANCE THE FOLLOWING PROJECTS, NAMELY: (A) COMPLETION OF PUBLIC MARKET, INCLUDING CONSTRUCTION OF ROADS AND/OR THOROUGHFARES AND DRAINAGE SYSTEM; (B) COMPLETION OF EVACUATION AND MULTI-PURPOSE CENTER, AS CONTAINED IN THE TERM LOAN AGREEMENT, DEED OF ASSIGNMENT AND OTHER DOCUMENTS RELATED THERETO SIGNED AND EXECUTED BETWEEN THE MUNICIPALITY OF BINMALEY AND THE DEVELOPMENT BANK OF THE PHILIPPINES AND TO FURTHER AUTHORIZE THE MUNICIPAL MAYOR TO ENTER/EXECUTE AND SIGN ANOTHER TERM LOAN AGREEMENT WITH DEVELOPMENT BANK OF THE PHILIPPINES (DBP) RELATIVE TO THE ADDITIONAL LOAN BORROWING IN THE AMOUNT OF EIGHTY THREE MILLION PESOS (P83,000,000.00) TO FINANCE THE FOLLOWING ADDITIONAL PROJECTS OF LGU, NAMELY: (A) CONSTRUCTION OF THIRTY TWO (32) HOUSING UNITS FOR THE BINMALEY RESETTLEMENT PROGRAM; (B) CONSTRUCTION OF COMMAND CENTER AND (C) CONSTRUCTION OF BINMALEY CENTRAL SCHOOL BUILDING" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Municipal Ordinance No. 7, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Officer and the Provincial Accountant, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 22 (a) (5) (c); 296 (b); 297 (a) (b) (c) and 444 (b) (vi) of RA 7160;

**WHEREAS**, however, the Sangguniang Bayan shall consider the observations raised by the Provincial Legal Officer in her opinion dated December 3, 2018, Provincial Planning and Development Officer in her opinion dated December 14, 2018, and the Provincial Accountant in his opinion dated May 17, 2019, all as attached in this Resolution;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Raul P. Sison and Nestor D. Reyes and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 7, S-2018 of the Sangguniang Bayan of **Binmaley**, Pangasinan, entitled “An Ordinance authorizing the local government unit of Binmaley thru its Municipal Mayor Honorable Simplicio L. Rosario for a loan borrowing in the amount of One Hundred Thirty Million Pesos (P130,000,000.00) to finance the following projects, namely: (a) completion of public market, including construction of roads and/or thoroughfares and drainage system; (b) completion of evacuation and multi-purpose center, as contained in the term loan agreement, deed of assignment and other documents related thereto signed and executed between the Municipality of Binmaley and the Development Bank of the Philippines and to further authorize the Municipal Mayor to enter/execute and sign another term loan agreement with Development Bank of the Philippines (DBP) relative to the additional loan borrowing in the amount of Eighty Three Million Pesos (P83,000,000.00) to finance the following additional projects of LGU, namely: (a) construction of thirty two (32) housing units for the Binmaley Resettlement Program; (b) construction of Command Center and (c) construction of Binmaley Central School Building” as within the conferred powers of the Sangguniang Bayan to enact;
