DECLARING MUNICIPAL ORDINANCE NO. 5, S-2022 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITION OF ADMINISTRATIVE ASSISTANT IV, SG 10, UNDER THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR OF THE EXECUTIVE DEPARTMENT OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
