RESOLUTION NO. 335-2019

DECLARING ORDINANCE NO. 057-2018 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE INVESTMENTS AND INCENTIVES CODE OF THE MUNICIPALITY OF LABRADOR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 057-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16, 109, 192 and 447 of RA 7160; RA 7042 (Foreign Investment Act of 1991); RA 7844 (Export Development Act of 1994); and RA 7916 (Special Economic Zone Act of 1995);

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to RA 7160;
