APPROVING RESOLUTION NO. 48-2020 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Resolution No. 48-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Urbiztondo, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on February 14, 2020 by the MDC thru Resolution No. 01, S-2020 and was favorably acted upon by the Sangguniang Bayan on February 17, 2020 thru SB Resolution No. 48-2020;

**WHEREAS**, the Supplemental Investment Program No. 1 of the municipality covers the fund augmentation for the Personal Services and Maintenance and Other Operating Expenses of some municipal offices, development projects and disaster risk reduction projects;
