DECLARING MUNICIPAL ORDINANCE NO. 2-2022 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 1 (A) (5) OF MUNICIPAL ORDINANCE NO. 6-2021, ENTITLED "AN ORDINANCE CREATING VARIOUS POSITIONS IN THE MUNICIPAL GOVERNMENT OF URBIZTONDO, PANGASINAN WITH CORRESPONDING SALARY GRADE AND ALLOCATING FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 2-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, the change of position title from Public Service Officer IV to Municipal Government Assistant Department Head (Assistant PESO Manager) is in accordance with the Qualification Standards issued by the Civil Service Commission and other related issuances;
