**APPROVING RESOLUTION NO. 19(A)-051 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 6 FOR CALENDAR YEAR 2019 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19(A)-051 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City Pangasinan prepared the City's Supplemental Investment Program (SIP) No. 6 for CY 2019. This was endorsed by the Council thru CDC Resolution No. 07-19 (S-2019) dated October 14, 2019 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 19(A)-051 dated November 4, 2019;

**WHEREAS**, said Supplemental Annual Investment Program which has a total investment requirement of P1,900,081.00 covers the cost/implementation of the following projects of the LGU, to wit:

**WHEREAS**, said realignment was the subject of Sangguniang Panlungsod Resolution No. 19(A)-052 of San Carlos City, Pangasinan;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
