APPROVING RESOLUTION NO. 293, S-2021 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 5 S. OF 2021 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 4 CY 2021 AMOUNTING TO ONE MILLION TWO HUNDRED TWENTY SEVEN THOUSAND SIX HUNDRED NINETY PESOS AND 88/100 (P1,227,690.88)”

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 293, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Bautista, Pangasinan had identified items in this Supplemental Investment Program No. 5 CY 2021 which was endorsed to the Sangguniang Bayan for approval on December 20, 2021 through MDC Resolution No. 5, S-2021;

WHEREAS, Supplemental Investment Program No. 5 covers fund augmentation for Personal Services and Maintenance and Other Operating Expenses of some municipal government offices;


