APPROVING RESOLUTION NO. 2018-172 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2018-06 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2018-172 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binalonan, Pangasinan has formulated the municipality's Supplemental Investment Program No. 06-2018 and endorsed thru MDC Executive Committee Resolution No. 6-2018 dated August 23, 2018 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 2018-172 dated August 28, 2018. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 6 of the municipality with an investment requirement amounting to P232,191.40 covers fund augmentation for the operation of the University of Eastern Pangasinan;
