APPROVING RESOLUTION NO. 8, S-2022 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED “APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPAL SUPPLEMENTAL BUDGET NO. 1, S-2022 OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 8, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of San Quintin, Pangasinan has formulated and endorsed the municipality’s Supplemental Investment Program No. 1 through MDC Resolution No. 01, S-2022 dated January 21,2022 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Investment Program No. 01 with an investment requirement amounting to Php10,944,974.44 covers fund augmentation for Personnel Services, Maintenance and Other Operating Expenses and Capital Outlay of some offices of LGU San Quintin;


