**APPROVING MUNICIPAL RESOLUTION NO. 141-2019 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED “APPROVING THE 2019 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF NATIVIDAD, PROVINCE OF PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Natividad, Pangasinan submitted its Municipal Resolution No. 141-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Natividad, Pangasinan thru MDC Resolution No. 06-2019 has endorsed the municipality’s Supplemental Investment Program to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan thru Municipal Resolution No. 141-2019 dated December 20, 2019;

**WHEREAS**, the Supplemental AIP with an investment requirement amounting to P843,900.00 covers the implementation of the grant of the Service Recognition Incentive to municipal officials and employees, and fund augmentation for disaster risk reduction and management of the municipality;

**WHEREAS**, the Sangguniang Bayan enacted Supplemental Budget No. 2 thru Appropriation Ordinance No. 02-2019 dated December 20, 2019 to support the implementation of the Supplemental Investment Program of the municipality;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
