## **RESOLUTION NO. 347-2022**

**DECLARING ORDINANCE NO. 3, S-2022 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF FOUR (4) ADMIN. AIDE III (UTILITY WORKER II), SALARY GRADE 3; THREE (3) IN THE OFFICE OF THE MUNICIPAL MAYOR AND ONE (1) IN THE OFFICE OF THE MUNICIPAL BUDGET OFFICER, THIS MUNICIPALITY, SAN QUINTIN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Ordinance No. 3, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
